### Website Segments: Website Is Divided Into Various Major Segments

Bizlinkindia is not responsible for any products or services you purchase from our platform, as bizlinkindia is providing third party support to its vendors to reach its customers. We are an integrated site that provides sales services and marketing support to sellers

- **Reference Code (RC):** The person who registered his name on [www.bizlinkindia.com](http://www.bizlinkindia.com) by agreeing to all the terms and conditions. At that time the user gets the Reference code / User code. (e.g. **BZ 670987**) When registering for the first time on the website, the reference code of any pre-registered user or business partner (BP) is required.
- **UPV: User Purchase value:** According to the actual purchase price collected from all the departments through the user company's website, the total price is known as UPV as per the business value determined by the company for each item to the user..
- **User:** The person who registered your name on [www.bizlinkindia.com](http://www.bizlinkindia.com) by agreeing to all the terms and conditions.  
E.g.: After registering on the company's website, the person will be treated as a user till he makes a total purchase of Rs. 1999 /-.
- **BP: Business partner:** Users make a combined purchase of ₹ 1999/- from all departments through the company's website, known as BP.  
The user himself becomes a business partner at the same time or in stages when he / she purchase any of the products worth at least Rs. 999 /- out of the total product displayed on [www.bizlinkindia.com](http://www.bizlinkindia.com). Cash back on purchases made by the business partner himself. Also its reference will be eligible for cash back on the total purchase price of the business partner linked to bizlinkindia.com.  
E.g.: When a person first buys Rs.500 /- after registering on [www.bizlinkindia.com](http://www.bizlinkindia.com). A few days later he bought it for Rs.1500 /-. At the time, he was a business partner. Because he has bought a total of Rs. 1999/- or more. This means that the business partner is eligible for cash back.
- **SBP: Senior business partner:**  
USER / BP register a new name for its close, acquaintances at [www.bizlinkindia.com](http://www.bizlinkindia.com). When registering a new user whose reference code is used. That USER / BP is promoted and it becomes SBP.  
i) SBP is eligible for cash back only on purchases made by BP.  
ii) SBP does not have any number limit for registering a new user under its own reference code. E.g. SBP can register at least 1 and unlimited new user / BP.
- **EBP: Executive Business Partner:**  
When an SBP qualifies at least 1 BP in his team to become an SBP, Then that SBP is promoted and becomes EBP.  
• EBP is eligible for cash back on purchases made by SBP and BP.  
ii) EBP is not a number constraint for SBP under its own reference code.  
E.g. EBP can generate at least 1 and unlimited SBP.
- **RBP: REGIONAL BUSINESS PARTNER:**  
When an EBP qualifies at least 1 SBP in his team to become an EBP, Then that EBP is promoted and becomes RBP.

### VARIOUS CASHBACK OPTIONS:

- **DCB: Direct Cash back:** BP / SBP / EBP with their own reference code on [www.bizlinkindia.com](http://www.bizlinkindia.com), the person / USER who is registered. DCB is the cash back that each person / USER receives on each total purchase made through the website.
- **ITCB: Indirect Turnover Cash back:** The BP / SBP / EBP has registered the person / USER under its own reference code. ITCB is the total cash back received by each member of his team / USERS / BP / SBP / EBP on each and every purchase made through the website.
- **Rewards:** The user registered the business name by prompting a vendor to register his business on [www.bizlinkindia.com](http://www.bizlinkindia.com). At that time the instigating user will be given Rs. 99/- to Rs. 499/- as Rewards.  
When the vendor registers the business name on the website, the vendor should use the user's reference code.
- **Eligibility for Cash Back / Reward:** User does not receive cash back. It becomes BP after the user himself makes a purchase of at least Rs. 999 /- through the website. And is eligible for cash back / rewards.

\* Business credit value: Based on the selling price of the item provided by the seller, BDML Company will determine the credit value of each item price for the user, subject to cashback or rewards. From that, the cashback will be given after deducting all kinds of government taxes.

### Promotion & Cash Back/Reward Process:

1) When a user joins Bizlinkindia through a website, he becomes a user. He gets the business code. This is also called reference code (RC). This reference code must be used when registering a new user. The person whose RC is inserted as a reference, his level is changed and he is promoted to a higher level.

E.g. Mr. Thomas is a Level-1 user. And Mr. Thomas's RC is BZ234499. If Mr. John uses the reference code BZ234499 when registering on [www.bizlinkindia.com](http://www.bizlinkindia.com), Mr. Thomas will add Mr. John here and Mr. Thomas will be promoted to Level-2 Business Partner (BP).

2) As per the example above, when a user registers a new user under him and he becomes a Business Partner (BP). But he is not eligible for cash back, because to get cash back, the user has to make a purchase of at least Rs. 999 /- from the website.

E.g. In the above example, if Mr. Thomas himself made a purchase of Rs. 999 /- through the website, then Mr. Thomas will get 10% direct cash back (DCB) of the total purchase price through Mr. John's website.

**Stopping Cash Back :** Users in their circle can be eligible for cash back / reward only after purchasing a minimum of Rs. 999/- through the website itself. If the user can take the promotion after joining, but under his BUSINESS code / RC the cash back / reward he gets on the purchase made by the user is stopped till he is eligible to get the user commission.

**CASH BACK/REWARD PROCESS:** This will be cash back / reward process based on the total purchase price generated in a month. The system automatically calculates its SBP / EBP / RBP from time to time according to each USER's purchase price. However, the rejected / reverse purchase will be processed every month by deducting cash back / reward, so that it will be credited to the user's bank account every month in 60 to 120 days after purchase from the website as per the demand of the user or in stages. USER's profile has a Withdraw REQUEST Option for Cash Back / Reward Request. USER's cash back amount will be sent in multiples of at least Rs.500.

### How do I create my Team/Circle and get cash back?

Bizlinkindia is a group of manufacturers and consumers. A person registers his name and mobile number (mobile number is registered only on ce). We call it user. The user can add at least one and at most new users using his reference number. When new users are added, they are considered in the first level of the direct team. USER is given 10% cash back on the total purchases of all the customers in the team created by the user.

**Step-1.** You first registered the mobile number and name on the Bizlinkindia website. (There is no registration fee.)

**Step-2.** The BC (Business Code) / Bizlink code / RC (Reference Code) system is automatically generated after registration. E.g. BZ-234499 (Reference code is used when adding a new USER inside you.)

**Step-3.** You have to buy the item for Rs. 1999 /- on [www.bizlinkindia.com](http://www.bizlinkindia.com). So your team / circle is eligible for cash back / rewards on the purchase price of USER.

**Step-4.** BP - Business Partner Degree.

- i) After purchase of Rs. 1999 /-
- ii) USER will be promoted to BP.
- iii) USER will be eligible for cash back.

**Step-5.** You get a cash back / reward of 10% of each purchase price after the purchase by the designated USER.

E.g. You have registered 1 new USERS under your BC / RC. In it, everyone bought for Rs 10,000. So UPV is  $10,000 \times 1 = 10,000$  UPV (USER PURCHASE VALUE).

**Step-7.** The 5 new USERS under one of the above SBPs registered 5 new USERS each below their BC / RC.

- i) 25 USERS of 5 SBPs / 5 new USERS of BP each means a total of 25 new USERS were added.
- ii) 5 BP. They will be promoted to SBP.5
- iii) 1 SBP. They will be promoted to EBP.
- iv) You were EBP. You will be promoted to RBP.

EXAMPLE :- 25 New USERS made a purchase of Rs. 10,000 each, while the total USER purchase price (UPV) was Rs. 2,50,000.

**YOU & YOUR Benefits-**

5 SBPs will get 10% cash back / reward.  $5 \text{ USERS} \times 10000 \text{ (UPV)} = \text{Rs. } 50,000 /-$   
 You are RBP. You will get 3% of UPV. That is  $2,50,000 \times 3\% = 7,500 /-$  cash back / reward.  
 EBP will get 5% cash back / reward. That is  $2,50,000 \times 5\% = 12,500 /-$  cash back / reward  
 SBP will get 10% cash back / reward. That is  $2,50,000 \times 10\% = 25,000 /-$  cash back / reward

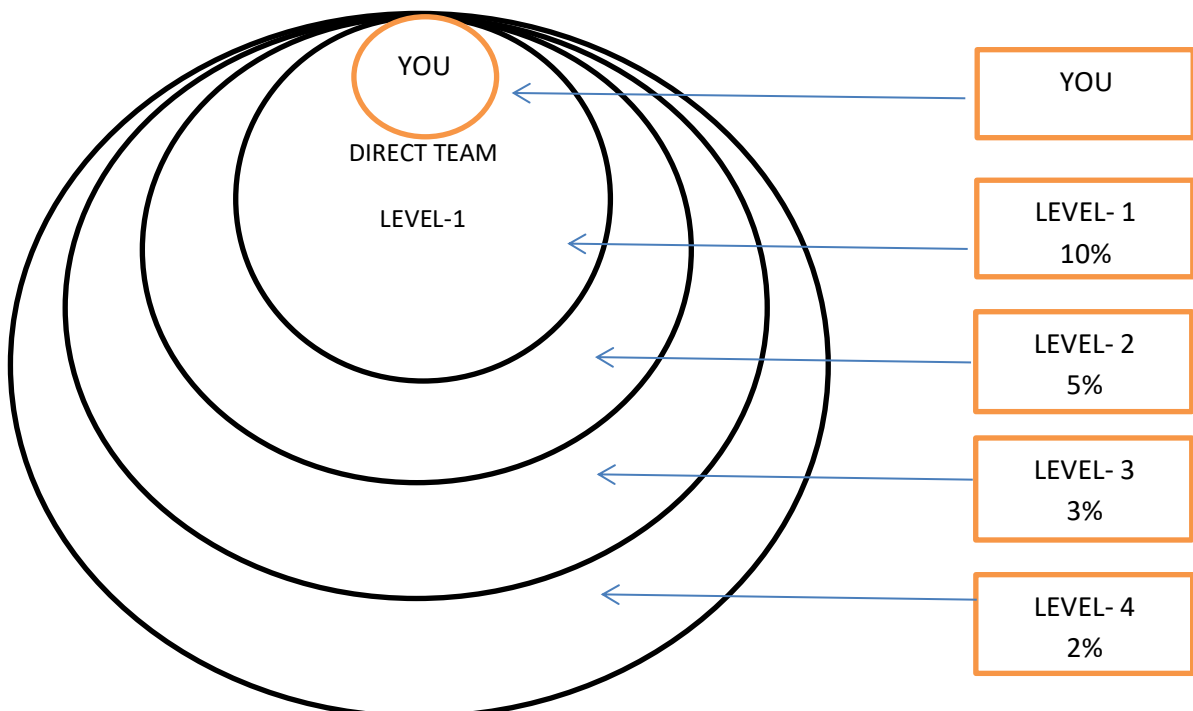
